2. **FY 25 RTA Funding Update**

R. Malnati discussed the uncertainty of BRTA funding. The Governor's budget is level funded at \$150M collectively and \$15M for discretionary DOT grants, with no CPI. The State revenues are also down from the previous year. The House will submit their budget mid-April and the Senate will submit theirs mid-May. The Federal apportionments have only been partially released; 5 months. Historically, BRTA receives \$2.9M, but is unsure of funding levels as it will use the 2020 census and ridership to calculate. BRTA ridership has been increasing.

3. FY 25 Draft BRTA Budget

R. Malnati presented the FY 25 BRTA Budget Assumptions. Union negotiations have begun for both the fixed route and paratransit. The BTM budget is large and likely to increase significantly. BRTA had a meeting with Senator Mark to discuss BRTA's funding levels. There was a discussion on diesel pricing staying stable or decreasing in FY25. BRTA's draft budget is at a standstill until more funding information is available from the Feds and State. This year there were 2 Try Transit Events and will also be 2 events in FY25.

4. Pension Contribution- VOTE

R. Malnati suggested contributing an additional \$50K in FY24 to the pension. Earlier in the year, it was voted to contribute between \$200K and \$250K to the pension. The contribution of \$200K was made as the final State budget amount was not known prior to the approval of the FY2024 Budget by the Advisory Board.

D. McNally made the motion to contribute an additional 50K in FY24 to the pension prior to June 30, was seconded by S. Lamb, and was approved by all.

5. MMDT-VOTE

R. Malnati shared the auditor's recommendation to use Mass Municipal Depository Trust (MMDT) for some BRTA funds. Currently BRTA uses a money market account with a low interest rate and has been shopping around for higher interest earning options. MMDT would provide another vehicle for large drawdowns, like the State funds which are somewhat predictable.

There was discussion on the interest amount and gathering of more information. D. McNally said to research this option and BRTA does not need the committee's approval to create an account. More information will be presented at the next meeting including potential funding recommendation.
